PRODUCT DESCRIPTION

Armourcoat Perlata is a water based decorative wall coating specially formulated with pearlescent pigments to create an elegant finish with a subtle surface shimmer. Perlata is available in a wide range of colours which are suitable for both modern and classical interiors.

The Perlata decorative coating comprises of a coat of Basecolor followed by two coats of Perlata.

Basecolor is a zero VOC, ultra-low Emissions high opacity base-coat primer that is used as part of the Perlata system.

MANUFACTURING AND PACKAGING (A1-A3)

The environmental impacts considered for the product stage cover the manufacturing of raw materials used in the production as well as packaging materials and other ancillary materials. Also, fuels used by machines, and handling of waste formed in the production processes at the manufacturing facilities are included in this stage. The study also considers the material losses occurring during the manufacturing processes as well as losses during electricity transmission.

Perlata And Basecolor are manufactured in the UK by Armourcoat Ltd. Armourcoat is fully accredited to ISO 9001, ISO14001, ISO 45001 and operates strict quality control procedures in the manufacture of all products.

The raw materials are checked, accurately weighed and mixed in batches in a specialist high shear mixer.

Each batch is allocated a specific batch number and a quality control check are performed on every batch.

Perlata is then packed into 6kg units using a vacuum packing dispenser.

Basecolor is packed into 5 litre units.

Finished product is packed onto a Euro pallet and stretch wrapped ready for warehouse storage.

All packaging (stretch wrap) and raw material packaging that fall below the 1% of mass threshold have been excluded for this study.

Pallets are based on a reuse scenario of two times. Most of the perlata orders are between 2- 20 units and therefore are not always sent out on a pallet and the pallets are recycled back to manufacture production.

TRANSPORT AND INSTALLATION (A4-A5)

Transportation impacts occurred from final products delivery to construction site (A4) cover fuel direct exhaust emissions, environmental impacts of fuel production, as well as related infrastructure emissions.

Perlata and Basecolor are manufactured in our UK Factory and transported by road for projects in the UK.

For UK projects the transportation distance is defined according to PCR norm.

Average distance of transportation from Armourcoat Ltd to building site is assumed as 100 km and the transportation method is assumed to be lorry. The material is hand applied by roller for the Basecolor and roller and trowel for the Perlata and therefore no additional energy or material is required in the application process.

It is estimated that 2% of the material is wasted in the application and this has been allocated to landfill.

Plastic buckets are assumed as single use and are sent for to waste disposal.

waste from Wooden pallets and buckets are assumed to be incinerated for generation of heat and electricity.

PRODUCT USE AND MAINTENANCE (B1-B7)

Perlata can be cleaned with a mild detergent. Perlata is very easy to patch and repair due to the natural tonal variations inherent in the finish. If the surface becomes badly scuffed the surface can be lightly sanded and a final pattern coat re-applied to the surface.

At the end of the installation phase a small quantity is left with the client for subsequent repairs if required. Provided it is kept in a sealed airtight container and stored in a cool environment it will remain usable for patch repairs for many years. The fact that it can be readily repaired significantly increases the useful life of the product.

No assumption has been made that the surface will be damaged and therefore the use stage (B1-B7) is outside the scope of this EPD.

Air, soil, and water impacts during the use phase have not been studied.

PRODUCT END OF LIFE (C1-C4, D)

Armourcoat Perlata forms a thin (50 -100um) layer on the substrate to which it is applied. It is impractical to remove it and therefore it is assumed that it will be recycled or disposed of at end of life along with the plasterboard substrate.

The consumption of energy and natural resources is negligible for the removal of the plasterboard, so the impacts of demolition are assumed zero (C1).

In the UK our products are approved for recycling with the plasterboard substrate.

It is assumed that the waste will be transported to the nearest construction waste recycling plant.

Countrystyle Ridham Recycling centre is 80km from central London (C2).

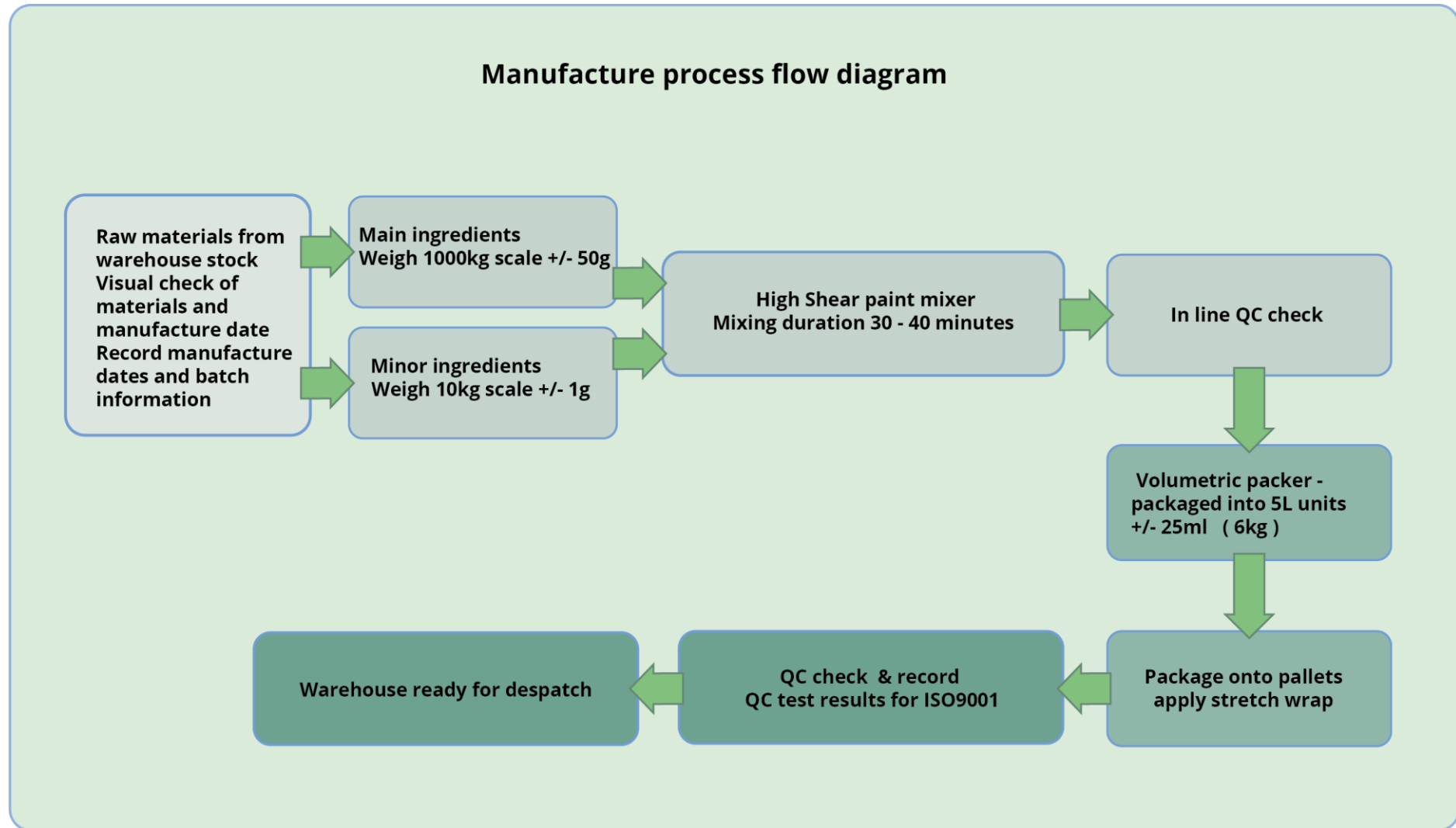
There is no waste processing for reuse, recovery or recycling of the actual Perlata product (C3).

Plasterboard is the most commonly used substrate for both commercial and residential projects and it is therefore assumed that it is likely to be treated as gypsum waste along with the plasterboard substrate. The dry

mass of the product at end of life is 0.0143 kg and it is assumed that this will be extracted during the plasterboard recycling process and sent to landfill (C4).

Wooden pallets and buckets are incinerated for generation of heat and electricity (D).

LIFE-CYCLE ASSESSMENT

CUT-OFF CRITERIA

The study does not exclude any modules or processes which are stated mandatory in the reference standard and the applied PCR. The study does not exclude any hazardous materials or substances. The study includes all major raw material and energy consumption. All inputs and outputs of the unit processes, for which data is available for, are included in the calculation. There is no neglected unit process more than 1% of total mass or energy flows. The module specific total neglected input and output flows also do not exceed 5% of energy usage or mass.

ALLOCATION, ESTIMATES AND ASSUMPTIONS

Allocation is required if some material, energy, and waste data cannot be measured separately for the product under investigation. All allocations are done as per the reference standards and the applied PCR. In this study, allocation has been done in the following ways:

Perlata is manufactured in three different base colours of white pearl, gold pearl and Bronze Pearl.

The formulation and mixing process is identical for all three colours and the only difference is the colour of the pearlescent mica.

The GWP and environmental impact is therefore the same for all products.

LCA SOFTWARE AND BIBLIOGRAPHY

This EPD has been created using One Click LCA EPD Generator. The LCA and EPD have been prepared according to the reference standards and ISO 14040/14044. Ecoinvent and One Click LCA databases were used as sources of environmental data.
